9. Church Wall and Bank

MSDC, on instructions from Poynings PC, have now repaired the wall and bank at the Church.

10. Cora's Corner

The Clerk advised the PC that the post supporting the sign at Cora's Corner is rotting away. A grant for the post was obtained by PPC last year for the replacement post but due to Covid this hasn't been purchased/fitted yet. The volunteers from WSCC, who were going to install it, are well behind schedule and won't be able to do it for the foreseeable future. A group of local volunteers will do it, but will need a steel plate made and concreted in. This would probably be in the region of £300. This was unanimously agreed.

The volunteer gardeners, supported by the PC, have made a good job of replanting Cora's Corner and it is still continuing. The PC thanked all those involved.

The Ivy by the arch is being removed and may need volunteers.

It was suggested by JD that the iron barricade is removed, there are concerns that it may then be used as a bridle path so this will be looked at at a later date.

11. Finger post

This sign at the roundabout was destroyed by joyriders last year and a new one has been manufactured under insurance. Hopefully this will be fitted in the next month.

The missing "Unsuitable for HGV's" sign has not been replaced by Highways although requested. Other options to be looked at.

12. Passing place

The "no parking" signs that were installed on the road between The Oak and the garage has been a success. However, two have been taken out. To put all three back with concrete this summer.

13. Winter plan

No more salt needed as none has been used for the last 2 years.

14. Defibrillator training

The clerk suggested that another Defibrillator training session should be organised. M Airey said he would organise this.
