# 8. Jubilee Sign - Permanent placement

# 9. Dyke road Closure - Snow

#### 10. Watershed

After discussion it was proposed by NS and seconded by JD that the Asset register, Standing orders, Code of Conduct, Risk assessment and Financial Risk assessment are adopted by the council. It was unanimously agreed to do this, and they were duly signed by the Chairman and Clerk.

#### 13. Village Gates

JD distributed photographs of the positions of the proposed village gates which had been approved by highways, hopefully to be funded by donation. Clerk to investigate costs etc. It is hoped to have Oak gates but Highways aren't keen as they have to break on impact.

#### 14. Elections 2023

Local Government Elections are on the 4 May 2023, If more than 5 people apply to be on Poynings Parish Council there will be a cost of about £1,000, if 5 or less there will not be a

Parish Council election and applicants will automatically be Councillors. More information at the next meeting.

# 15. Annual Parish Meeting

The Clerk requested that the councillors think of a speaker for the Annual Parish meeting. Suggestions are: Local community Police officer, Campaign for Rural England. National Trust.

# 16. Budget/Precept 2023-2024

Proposed budget had been circulated to councillors. As the number of residents has reduced this year, even though the suggested increase is 10% which is less than inflation (to balance projected income and expenditure), the actual increase to Residents would be 10.70% which would be 13p a week, £6.76 pa.

The precept was proposed by JD and seconded by MC and was agreed unanimously.

#### 17. FTTP Broadband

The clerk advised that the Fibre to the premises broadband, that was applied for by the PC, rollout has now started.

#### 18. Village Hall

The clerk advised that the Platinum Jubilee grant can only be applied for by the Freeholder of the Village Hall. JD to approach the village hall trust and the Clerk is to look at lottery funding. MC passed out more detailed drawings of the possible development.
